

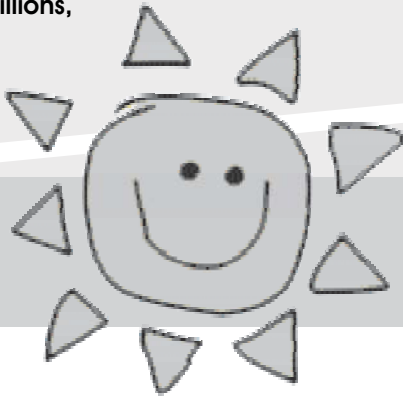

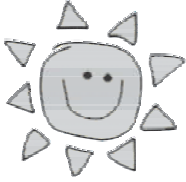

Our Retail trading terms and conditions are the following:

We are quite happy to send out any and all of your orders placed online, or over the phone. We ask that all goods are paid for in advance either by online banking' or by credit card. If done over the phone, we will ask for the cards CCV number which is located on the back of the card. For all retail transactions, your receipt will be posted out along with your goods.
Payment by Visa, Mastercard, Bankcard.

Payments made by cheque should be made out to **St George Business Finance Pty Ltd.**

Direct Deposit to St George Business Finance BSB 332-022 Account No 720 126 189. Branch Address - 50 Carrington Street, Sydney. Payment must be made prior to dispatch of goods.

Subsequent Orders -Approval of Account Facilities is at the discretion of **Compendium Australia Pty Ltd** and upon completion of Compendiums Account Application form.

Terms are strictly 30 days from date of invoice. Accounts that remain overdue for more than 30 days will attract a fee not in excess of the Bank prime interest rates

Delivery of Orders

Unless otherwise specified goods will be delivered by Toll.Ipec and a delivery charge will be levied. Charges will vary dependent upon your locality and the size and weight of your order.

Freight will be to your account. We endeavor to pass on to you the lowest obtainable freight rates. Our freight charges are exactly what we are charged by the freight company (or postal office) to get the goods out to you. It is not Compendiums policy to make money from freight. If there are any queries as to the freight charges in wholesale or retail, please let us know so that we can rectify any possible mistakes or problems .Compendium Australia will pay this charge on your behalf and charge accordingly on each invoice (unless otherwise notified). We understand it is in both our interests to keep charges as low as possible.

Faulty Goods. Returns will only be accepted with prior authorisation. Any claims must be made within 7 days of receipt of goods. Goods may only be returned by a canner approved by us.

Pricing -All prices are quoted in Australian Dollars and may change without prior notification.

No subsequent orders will be filled until an outstanding invoice is paid in full. We reserve the right to charge administration charges if payment is not received within 30 days. Goods will be invoiced at the prices ruling at the time of despatch.

The company's policy is to constantly improve its products. We therefore reserve the right to change specifications, colours and prices of any products at any time without notice or obligation
